

VOLUNTEER SERVICE AGREEMENT

- I. As a volunteer under the supervision of the Community Engagement Department(CED) at Palm Valley Animal Society(PVAS), I agree to and understand the following:
 - 1. I will not be compensated monetarily for the work I do with PVAS; I do this voluntary work of my own volition and free will.
 - 2. I must complete/attend Volunteer Orientation(s), Workshop(s), Online Training(s), and scheduled shift(s) as scheduled or required.
 - 3. I will submit all required documents, e.g., Volunteer Service Agreement, Training Certifications, and other documents provided by CED in a timely manner; it may hinder my registration process.
 - 4. I must adhere to the department's sign-in and sign-out process, and wear my name badge and any current volunteer uniform at *all* times.
 - 5. I will become familiar with the department's handbook, policies, and procedures and uphold its mission, philosophy, standards, rules, and regulations.
 - 6. I will conduct myself with dignity, courtesy, and consideration for others(animals, staff, or members of the public) and will work professionally and ethically.
 - 7. I will carry out my assignment(s)/shift(s) within the selected time frame and seek assistance from the supervisor whenever necessary.
 - 8. I will take any job-related problems, concerns, or suggestions to a CED Coordinator, Supervisor, or CED Manager.
 - 9. I must notify a CED Coordinator or Supervisor when I choose to discontinue my volunteer services.
 - 10. I will use social media responsibly and positively represent PVAS, its animals, its programs, and its staff. No photo/video recordings while in the vet clinic or medical rooms are allowed unless otherwise requested by CED Representatives.
 - 11. I will immediately report any accident or injury to my supervisor and cooperate with the completion of an accident/injury form.

II. Vaccinations

1.	PVAS feels it is important to have a tetanus vaccination before joining the volunteer team, but it is not required to

III. Failure to Comply

- 1. I understand that PVAS reserves the right to terminate my volunteer status as a result of, the following:
 - a) Failure to comply with organizational policies, rules, or other regulations
 - b) Unsatisfactory attitude, work, or appearance
 - c) Any other circumstances which, in the judgment of PVAS, would make my continued service as a volunteer contrary to the best interest of the shelter
 - d) Inappropriate use of social media as related to PVAS and my position

IV. Confidentiality and Privacy Policy

A. PVAS volunteers may have access to confidential information (e.g., name, address, financial, or personal information) about the organization's clients, donors, fellow volunteers, and families that interact with our organization. It is of the utmost importance to PVAS that this information is maintained in the highest degree of confidence and that it is accessed only on a need-to-know basis. For that reason, unauthorized use of confidential information may result in loss or suspension of volunteer status.

V. Handling of Animals

- A. I understand that the behavior of domestic and shelter animals can be unpredictable and that some animals are capable of inflicting serious personal property damage, injury, or death. I agree to assume these risks and to release, indemnify, and hold harmless PVAS, its employees, and board members for any and all personal injury and property damage resulting from my volunteer work.
- B. It is recommended, but not required, for the health of one's personal pets that they are up to date with vaccines and preventatives and that PVAS is not responsible for providing care to any pets not under the care of PVAS.
- C. I will complete any required training before handling any animal(s).
- D. I will not interact with any animal(s) without the required proper training or permission.
- E. I will wear proper PPE(personal protective equipment) where/as required.
- F. I will never strike an animal, handle it, or treat an animal in such a manner that can be deemed as rough or abusive.

VI. Consent for Audio-Visual Images:

I grant permission to PVAS to use my image, the image of my Junior Volunteer(s) (photographs and/or video) for use in publications, including videos, email blasts, recruiting brochures, newsletters, and magazines, and to use my image in electronic versions of the same publications or on the website or other electronic forms of media. I hereby waive any right to inspect or approve the finished photographs or electronic matter that may be used in conjunction with them now or in the future, whether that use is known to me or unknown, and I waive any right to royalties or other compensation arising from or related to the use of the image.

I have read and understand each of the above conditions. My signature below indicates that I release PVAS its animals, staff, anyone employed by PVAS from any responsibility or liability. I agree to be bound by them and that I have accurately, knowingly, and truthfully completed the Palm Valley Animal Society Volunteer Registration, Volunteer Service Agreement, and Junior Volunteer Release*.
